7. Creating a Basic Bible Study Layout

- Shows how to open multiple resources for Bible Study (Example: 3 Bibles, a Bible Commentary, Bible Atlas, and Bible Dictionary
- Shows how to LINK the proper resources
- Shows *a way* of arranging resources for ease of study (dragging, enlarging windows)
- Shows how to create and save a LAYOUT for future use

8. Basic Concordance Search and Floating Windows

- Shows how to FLOAT a window for momentary viewing
- Shows how to DOCK a window that has been "floating"
- Shows the procedure for doing a concordance search of a word(s) in the Bible
- Shows how to narrow the results of a concordance search

9. Basic Skills for Making Notes – Part 1

- Discusses the need for making notes for words in your Bible
- Shows how to highlight a word in the text and create a note for it
- Shows how notes can be enhanced by bold, italics, underline, etc.
- Shows how the same process can be used for a phrase (several words)
- Shows how information can be copied from other resources and added to a note

• Shows how to copy & paste information from a resource like a Bible Dictionary into a note

- Shows how to directly access Wikipedia from within Logos and copy & paste text into a Logos note
- Shows how to find a selected web page on a web browser and make a link to that page within a Logos note

- Provides a general introduction to studying the meaning of words
- Clarifies that words have a "range of meanings," and the use in a particular verse must be contextually determined
- Covers the process of researching words and offers a practical way of proceeding

14. Studying Biblical Words in their Original Language – Part 2: Gk Lexical Resources

• Introduces five lexicons and lexical resources that are suitable for those not trained in the Greek language

15. Studying Biblical Words in their Original Language – Part 3: Gk Concordance Searches

- Explains the importance of doing a concordance search from the original language
- Clarifies the meaning of the word "lemma" (the form a word appears in the lexicon)
- Explains how to use Logos to do a concordance search of the Greek word lying behind any given English translation

16. Advanced Skills for Making Notes – Part 4: Accessing Greek Lexicons

- Introduces the Logos "Bible Word Study" feature
- Provides a guided tour of "Bible Word Study," pointing out the various kinds of information that this feature provides, including a list of lexicons found in your version of Logos
- Shows—as an example—how to open two lexicons, the DBL and the Lexham Gk Lexicon, and highlights the differences between them
